ECONOMIC SECURITY FOR ALL (ECSA)

The Workforce Initiatives Grants Management Office—Employment Security Department shared presentation about the initiative for building locally developed approaches for restructuring access to existing services and benefits, helping more low-income families move out of poverty.

This initiative funded by Workforce Innovation and Opportunity Act (WIOA) statewide activities funds and local programming and partnership efforts are led by Local Workforce Development Boards (LWDB)

TEACHER RESIDENCY UPDATE

Jim Meadows, Dean of Educator Career Pathways Center, provided an update on the WEA Emergency Sub Teacher Project and the WEA Teacher Residency Apprenticeship.

Currently, aspiring educators from three school districts are participating in the residency program to become special education teachers. This is a teacher certification residency program where candidates will earn a special education endorsement.

During the 2024-2025 school year, the WEA Teacher Residency is partnering with the following school districts and local unions: Auburn, College Place, Federal Way, Mukilteo, Pasco, Peninsula, Sedro-Woolley, Sumner Bonney-Lake, and Walla Walla. Applicants must have completed a bachelor's degree or higher prior to the program start state. Applications are due April 12.
